What is Lobular Breast Cancer?

Lobular Breast Cancer makes up **15% of all diagnosed breast cancers.** It is the 6th most common cancer in women in the UK.

22 people in the UK are diagnosed with Lobular every day. That's equivalent to two football teams.

Lobular rarely forms a lump, making it hard to see on scans. As a result, it is often diagnosed at a late stage, requiring more extensive treatment, or even being first diagnosed as secondary disease.

It is an **under-studied and misunderstood disease** that needs better research and treatments.

Despite the evidence, **Lobular is not recognised as a distinct disease** in treatment guidelines across the UK.

Trustee Roles



What we need

You don't need to have been a Trustee before. We want you to be passionate about getting involved, align with our purpose and values, bring different experiences and ideas, and are open to challenging the way things are done.

We are particularly keen for people from ethnically diverse communities, with experience of a metastatic Lobular diagnosis, or people living in Northern Ireland and Wales, to apply.

Skill areas we need are:

- communications, especially working with the media;
- campaigning to change health policy and guidelines;
- digital and data skills and strategy e.g. Al adoption, collecting and using data, cyber security and GDPR;
- health economics.

But please still apply if you do not have these skills and can bring passion and valuable lived experience.



Trustee Legal Responsibilities

- To ensure we are carrying out our charity's purpose and provide benefit to the public.
- To make sure that we comply with our governing documents and charity law.
- To always act in the best interest of LBCUK.
- To make sure we operate responsibly, taking care of our reputation, finances, and limiting risk.
- To commit your experience, knowledge and skills to the role, using them to make appropriate decisions, and take the best actions for the charity.
- To ensure we are accountable and transparent in all we do.

Trustee Commitment

- Attendance at four Board meetings a year. Our meetings take place on Zoom and last between 2 - 3 hours.
- Attendance in person at our Annual Strategic Planning session that takes place over two days.
- In addition, you may be asked to be a member of a board committee. These are more operational and can meet more regularly on Zoom.
- You will be expected to represent the charity at 2 additional events each year, for example an information day for a partner or to attend a conference.
- Whilst this is a volunteer role, reasonable travel and subsistence expenses will be reimbursed.
- The term of appointment will initially be for 3 years with a review of performance for a further three years, to a maximum of nine years.
